FOOD, CLOTHING, WATER, HYGIENE ITEMS, AND HOUSEHOLD GOODS ARE DISTRIBUTES TO INDIVIDUALS AND FAMILIES, AS WELL AS TO OTHER AGENCIES SERVING PEOPLE IN NEED. 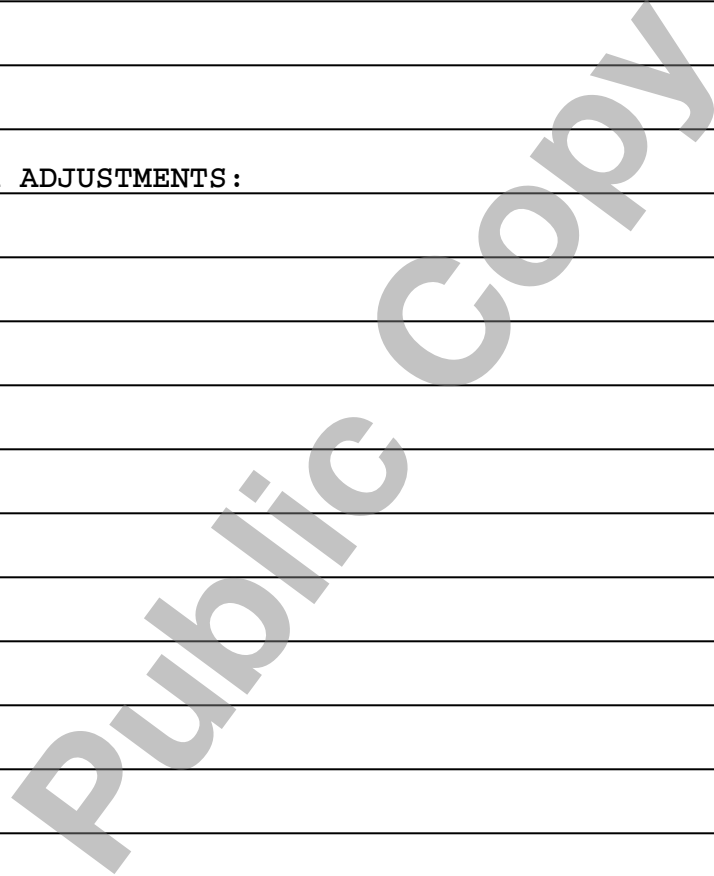

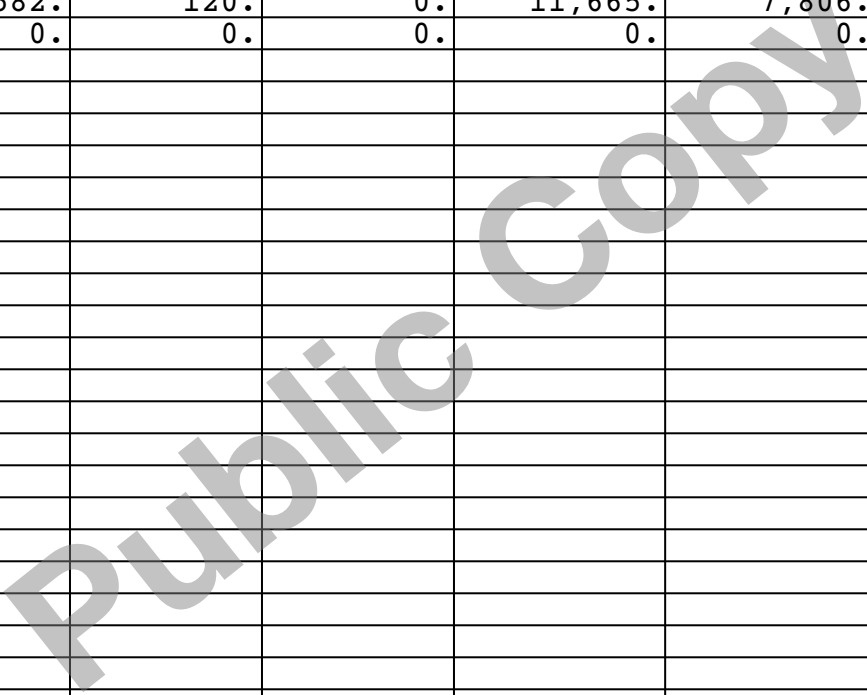

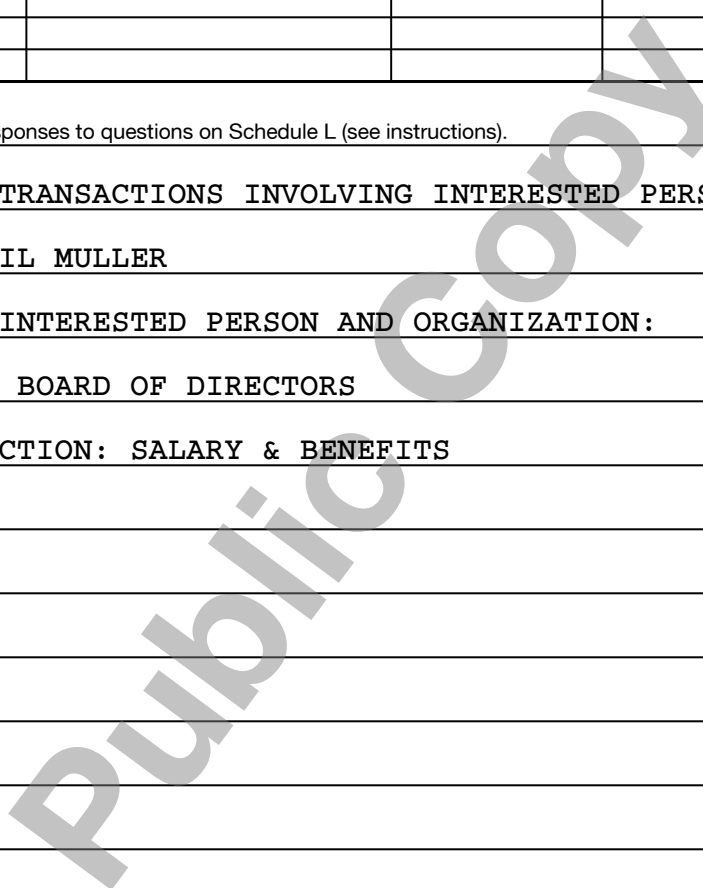
